SB601 – chaptered – has been signed by governor

5 of 6 is passing the fitness gram. This allows the student to access the exemption. Non passing students will need to take four years of PE.

CAHPERD is working on a fitness testing specialist program for CA. Human Kinetics willing to publish the program when it is completed. Should not be used to grade students or evaluate teachers.
